whilst operating **Worldwide**, excluding Official War Areas and / or Countries / Regions under **United Nations** sanctions and / or Countries / Regions as per Kiln Geographic Areas Exclusion Clause **LSW 617G**, against risks and up to the limits, as follows:

**1/ HULL "ALL RISKS"** – coverage provided of loss or damage to the Aircraft whilst flying and/or on the ground, for an Agreed Value of **US\$ 7,000,000** including two CFM-56-3B2 Engines M.S.N. 720984 and 722333 / APU GTCP85-129E with M.S.N. P-60320, subject to a Deductible of **US\$ 50,000** each loss, other than in the event of Total Loss, Constructive Total Loss or Arranged Total Loss.

**2/ AIRCRAFT LEGAL LIABILITY COVERAGE - COMBINED SINGLE LIMIT** of **US\$ 600,000,000**, including Aircraft Third Party Legal Liability Limit of not less than **SDR 300,000,000**; Passenger Legal Liability Limit of **SDR 250,000** per one passenger (there are 4 pax seats covered on board); Cargo and Mail Legal Liability Limit of **SDR 19** per kilogram /carriage of declared values, livestock and perishables are **EXCLUDED** from Coverage/. Coverage also includes War and Allied Risks in accordance with the Extended Coverage Endorsement (Aviation Liabilities) **AVN.52D/E** with the Sub-limit up to **US\$ 600,000,000**. The Coverage provided allows carriage of "Dangerous Goods", subject to (i) the Aircraft is operated in accordance with its valid Certificate of Airworthiness, Air Operator Certificate or permit to fly, (ii) all Air Navigation Regulations are completed and (iii) carriage of such goods is in accordance with **IATA / ICAO** regulations and/or requirements of the appropriate Civil Aviation Authority (iv) all necessary permissions for such flights are obtained prior such flights. The Policy contain standard General Exclusions relating to Nuclear Risks (Nuclear Risks Exclusion Clause **AVN.38B**) and Pollution and Contamination Risks (Noise and Pollution and Other Perils Exclusion Clause **AVN.46B**).

In accordance with Customer's undertaking in Part 1, Article 13.1 of the **CSGTA** it is further noted and agreed that "**Boeing**" are included as **Additional Insured** for their respective rights and interests.

Date Recognition Exclusion Clause (**AVN.2000A**) written back in accordance with the Date Recognition Limited Coverage Clauses (**AVN.2001A/AVN.2002A**) as applicable.
